



**Addendum to existing POA executed by Client in favour of Tipsons Stock Brokers Pvt. Ltd.**

Dear Client,

With reference to the SEBI circular on handling or client's securities by Trading Members / Clearing Members vice circular no. CIR/HD/MIRSD/DOP/CIR/P/2019/75 dated 20<sup>th</sup> June, 2019, following clauses of the KYC / POA stands amended to comply with the said circular:
